

Bracket 1

The bracket is organized into four rounds of matches. The top half of the bracket (seeds 1-8) and the bottom half (seeds 9-16) follow a similar progression. The top half culminates in a match between [1] Matthew TOTH and [4] Duncan MAXWELL, while the bottom half culminates in a match between [2] Harry FREEMAN and [7] Mitchell KAHNERT. The final match is between [1] Matthew TOTH and [2] Harry FREEMAN.
